

## THE CITY OF FREMONT, OHIO

### *Journal of Council*

*December 1, 2016*

The regular meeting of Fremont City Council was called to order at 7:30 p.m. in the form prescribed by the General Rules of Council. President Hafford called the meeting to order. The following members answered roll call: Taylor, Knisely, Koebel, Otte, Zilch, and Stout. Councilwoman Ruiz was absent. The minutes for council meeting held on November 17th were approved.

First reading of a resolution authorizing and supporting the Black Swamp Conservancy's endeavor to preserve land in the City of Fremont and declaring an emergency. Mayor Sanchez commented on the effort of the Black Swamp Conservancy to utilize the property located at the River Cliff Golf Course to preserve the land. He explained that the grant required that both the City and the Ballville Township needed to pass a resolution to support this endeavor. He explained the benefits for the city and township which included bringing in more tourists to the community and the banks of Sandusky River for fishing and recreational use of the river once the dam comes down. The property will be purchased by the Black Swap Conservancy and then deeded to the Sandusky County Park District. Both Rob Krain, Executive Director of the Black Swap Conservancy and Andy Brown, Director of Sandusky County Parks District both spoke of the advantages of obtaining this property. On motion to suspend Rule 4 by Mr. Knisely and seconded by Mrs. Stout. Motion carried 6 yea votes. On a motion to adopt by Mr. Knisely and seconded by Mr. Taylor. Motion carried 6 yea votes. Res. 2016-1996

First reading of an ordinance amending the pay scale for all part-time, intermittent, temporary, seasonal, and interim employees, and boards and commissions of the City of Fremont, and declaring an emergency. Mr. Grahl explained this was in ordinance increasing the minimum wages for our employees. On motion to suspend Rule 4 by Mr. Koebel and seconded by Mr. Knisely. Motion carried 6 yea votes. On a motion to adopt by Mr. Taylor and seconded by Mr. Zilch. Motion carried 6 yea votes. Ord. 2016-3830

On a motion to show no objections to the CVS liquor license for wine and Sunday sells by Mr. Knisely and seconded by Mr. Taylor, the council voted 6 no objections.
