Journal of Council November 3, 2016

The regular meeting of Fremont City Council was called to order at 7:30 p.m. in the form prescribed by the General Rules of Council. President Hafford called the meeting to order. The following members answered roll call: Zilch, Ruiz, Stout, Taylor, Knisely, Koebel and Otte. The minutes for council meeting held on October 20th were approved.

Before the regular meeting, there was a presentation from Kathy Boukissen, Director of Development of the Hayes Presidential Library. She thanked the council for their financial support in bringing the Ohio State University Band to Fremont for the Centennial. She then presented the council with a token of appreciation in the form of a framed picture of the Ohio State performance.

Third reading of a resolution adopting the Solid Waste Management Plan for the Ottawa-Sandusky-Seneca Joint Management District. Tim Wasserman updated the council and gave an overview of the Solid Waste Management Plan. On a motion to adopt by Mrs. Ruiz and seconded by Mr. Taylor. Motion carried 7 yea votes. Res. 2016-1994

Second reading of an ordinance to make a donation of city dirt in the amount of \$11,500.00 to Rimelspach Farms and Produce Co. (Rimelspach) for the benefit and welfare of the citizens of the City of Fremont and declaring an emergency.

First reading of an ordinance amending appropriations within Water Operating Fund 510, and declaring and emergency. Mr. Grahl explained that this was an appropriation and then the money would be moved into the Water Replacement/Improvement Fund. On motion to suspend Rule 4 by Mrs. Ruiz and seconded by Mr. Knisely. Motion carried 6 yea votes to 1 no vote. On a motion to adopt by Mr. Knisely and seconded by Mrs. Ruiz. Motion carried 6 yea votes to 1 no vote. Ord. 2016-3824

First reading of an ordinance authorizing a fund transfer from Water Operating Fund 510 into Water Replacement/Improvement Fund 541, for the City of Fremont, State of Ohio and declaring and emergency. On motion to suspend Rule 4 by Mr. Knisely and seconded by Mrs. Ruiz. Motion carried 6 yea votes to 1 no vote. On a motion to adopt by Mr. Knisely and seconded by Mrs. Ruiz. Motion carried 6 yea votes to 1 no vote. Ord. 2016-3825

First reading of an ordinance approving the editing and inclusion of certain ordinances as part of the Various Component Codes of the Codified Ordinances of Fremont, Ohio and to amend or enact sections of the Traffic, General Offenses, and Fire Prevention Codes to conform to enactments of the General Assembly. Mr. Melle explained that this ordinance basically just cleans up ordinances to reflect the changes in the state.

First reading of an ordinance to authorize the expenditure and direct the Safety Service Director to enter into a contract with Calgon Carbon Corporation in an amount not to exceed \$366,762.00 for the Granular Activated Carbon Replacement Project and declaring an emergency. Mr. Myers explained that granular activated carbon was lastly replaced in 2005. This ordinance will allow for a new layer to be placed in the plant and save the city money by making a lump sum payment now. On motion to suspend Rule 4 by Mr. Koebel and seconded by Mr. Knisely. Motion carried 7 yea votes. On a motion to adopt by Mr. Knisely and seconded by Mrs. Ruiz. Motion carried 7 yea votes. Ord. 2016-3826

First reading of a resolution appointing two (2) representatives to serve on the City of Fremont's Community Reinvestment Area Housing Council and declaring an emergency. Mr. Gross explained that ORC requires a housing council to be in place for the city's Reinvestment Areas. Representatives recommended from City Council are Kathy Stout and Dan Henning. On motion to suspend Rule 4 by Mr. Knisely and seconded by Mrs. Ruiz. Motion carried 7 yea votes. On a motion to adopt by Mr. Knisely and seconded by Mrs. Ruiz. Motion carried 7 yea votes. Res. 2016-1995
