

ORDINANCE NO. 2016 - 3828

AN ORDINANCE APPROVING THE EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PART OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF FREMONT, OHIO AND TO AMEND OR ENACT SECTIONS OF THE TRAFFIC, GENERAL OFFENSES, AND FIRE PREVENTION CODES TO CONFORM TO ENACTMENTS OF THE GENERAL ASSEMBLY.

WHEREAS, various ordinances of a general and permanent nature have passed which should be included in the Codified Ordinances of Fremont, Ohio; and

WHEREAS, numerous sections of the Traffic, General Offenses, and Fire Prevention Codes need to be updated so as to conform to enactments of the General Assembly.

THE FREMONT CITY COUNCIL OF FREMONT, STATE OF OHIO, DOES ORDAIN AS FOLLOWS:

SECTION 1. That the editing, arrangement, and numbering or renumbering of those ordinances incorporated in the 2016 Replacement Pages are hereby approved as parts of the various component codes of the Codified Ordinances of Fremont, Ohio, so as to conform to the classification and numbering system of the Codified Ordinances.

SECTION 2. The following sections of the Traffic, General Offenses, and Fire Prevention Codes, as amended, are hereby approved and adopted as amended or enacted so as to conform to enactments of the Ohio General Assembly:

- 335.021 Ohio Driver's License Required for In State Residents. (Added)
- 335.09 Display of License Plates. (Amended)

- 335.111 Registration Within Thirty Days of Residency. (Added)
- 335.12 Stopping After Accident Upon Streets. (Amended)
- 335.13 Stopping After Accident Upon Property Other Than Street (Amended)
- 373.02 Riding Upon Seats; Handlebars; Helmets and Glasses. (Amended)

General Offenses Code

- 501.06 Limitation of Criminal Prosecution. (Amended)
- 529.01 Liquor Control Definitions. (Amended)
- 529.07 Open Container Prohibited. (Amended)


Fire Prevention Code

- 1519.04 Fireworks Possession, Sale or Discharge Prohibited. (Amended).

SECTION 3. A copy of such ordinances or parts of ordinances as edited, arranged, numbered or renumbered as parts of the Codified Ordinances is attached to this Ordinance in the form of 2016 Replacement Pages to the Codified Ordinances.

SECTION 4. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Revised Code of Ohio.


SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication after the earliest date according to law.




